GENESIS HOUSE IS A 36-BED STATE LICENSED RESIDENTIAL DRUG TREATMENT PROGRAM FOR ADULTS WITH SUBSTANCE USE DISORDERS. THE PROGRAM OFFERS SPECIALTY SERVICES FOR PERINATAL (PREGNANT AND POSTPARTUM) WOMEN. SIX CHILDREN UP TO THE AGE OF 5 MAY LIVE WITH THEIR MOTHERS WHILE THEY ARE IN TREATMENT. SERVICES INCLUDE MEDICALLY SUPERVISED DETOXIFICATION AND ONGOING MEDICAL SUPPORT, ASSESSMENT, TREATMENT PLANNING, INDIVIDUAL, GROUP AND FAMILY COUNSELING, RELAPSE PREVENTION, PARENTING EDUCATION, DISCHARGE PLANNING, REFERRALS TO ANCILLARY SERVICES AND AFTERCARE. THE CO-ED PROGRAM TREATED 307 INDIVIDUALS WITH 8,767 DAYS OF SERVICE, WHILE THE PERINATAL PROGRAM SERVED 6 INDIVIDUALS WITH 117 DAYS OF SERVICE. GENESIS HOUSE IS ACCREDITED BY THE COMMISSION ON THE ACCREDITATION OF REHABILITATION FACILITIES (CARF). IT IS FUNDED BY MONTEREY COUNTY

THE CLINIC IS STATE LICENSED FOR 285 TREATMENT SLOTS AND ACCREDITED BY THE COMMISSION ON THE ACCREDITATION OF REHABILITATION FACILITIES (CARF). METHADONE MAINTENANCE IS A COMPREHENSIVE TREATMENT PROGRAM THAT INVOLVES THE LONG-TERM PRESCRIBING OF METHADONE AS AN ALTERNATIVE TO THE OPIOID ON WHICH THE PATIENT WAS DEPENDENT. TREATMENT CONSISTS OF BRIEF, OUTCOME-FOCUSED THERAPY USING EVIDENCE-BASED PRACTICES SUCH AS COGNITIVE BEHAVIORAL THERAPY, SEEKING SAFETY AND MOTIVATIONAL INTERVIEWING.
